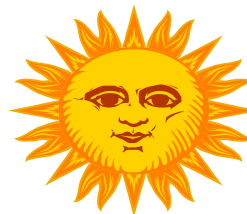

Indemnity and Release of Liability

In consideration of my being permitted to participate in the events or activities and/or functions (all of which are referred to as "the events") offered or organized by The Outdoor Club of Victoria, I hereby for myself, my heirs, executors, administrators, and assigns release and forever discharge The Outdoor Club of Victoria, their directors, officers, managers, servants, agents, volunteer leaders and participants (all of which are now referred to as the "Club") from any and all lawsuits or actions, claims or demands by reason of any damage, loss, death or injury to myself or to my property arising from my participation in events notwithstanding that the same may have been contributed to or occasioned by the negligence of the *Club*.

I agree to save harmless and indemnify the *Club* from and against all lawsuits, claims, actions, costs or expenses in respect to any death, injury, loss or damage to myself or my property howsoever caused arising out of or in connection with the events and whether or not the same may have been contributed to or occasioned by the negligence of the *Club*.

I recognize and acknowledge that there are inherent risks and hazards involved in participating in the events including, the possibility of becoming lost, changes in weather, falls on wet, slippery, rough or steep terrain, transport by public or private motor vehicle, as well as all other hazards associated with hiking, wilderness travel and other pursuits of the *Club* and agree to assume all such risks and hazards, and I further agree to bear all costs of rescue or medical attention rendered to me personally arising from the events.

I am aware the members of the *Club* acting as trip coordinators (volunteer leaders) of the activities and events are not professional leaders, guides, or licensed first aid attendants. I am aware they may not have completed an outdoor leadership course or have first aid (including wilderness) training or experience and they are not responsible for my safety or that of the guests or children I bring while participating in any activity.

I am aware that other participants with me in the activities and events are not responsible for my safety or that of the guests or children that I bring.
